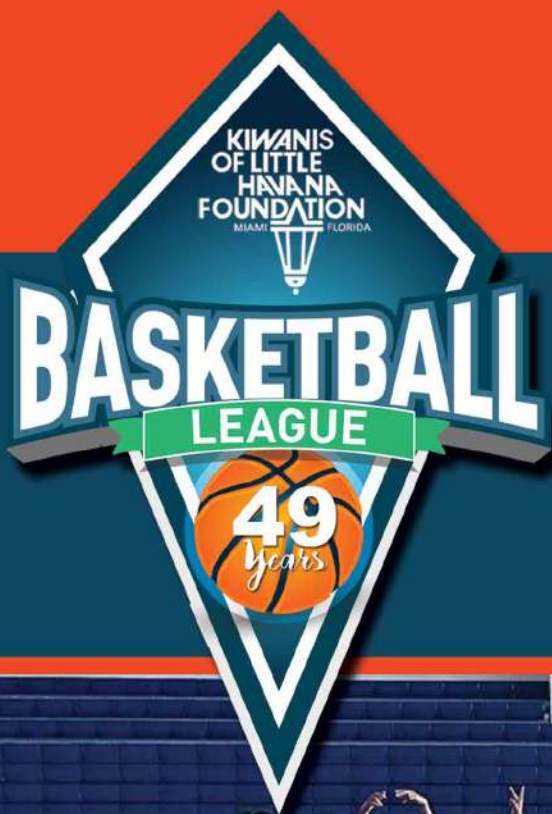

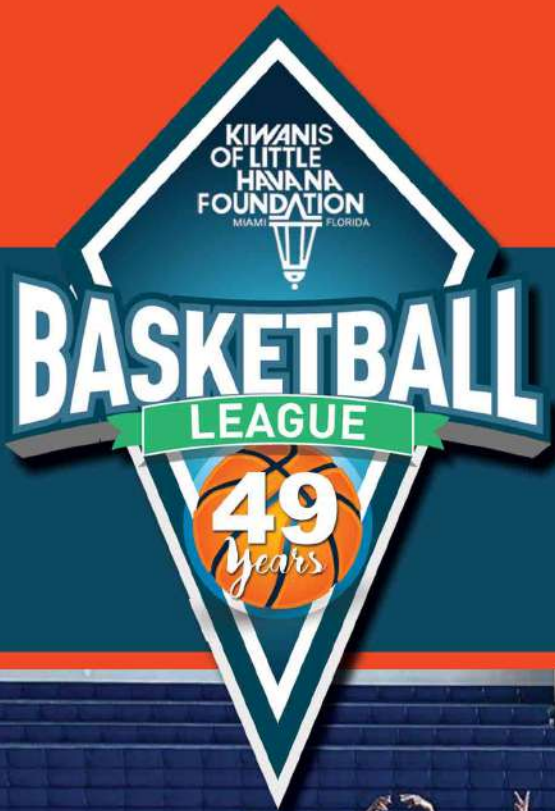

This Waiver and Release of Liability; Indemnification and Hold Harmless Agreement (the “Agreement”) contains important information and provides for the release of significant legal rights related to participation by the Participant identified above in the **KIWANIS OF LITTLE HAVANA FOUNDATION** (“Basketball League”) operated by **KIWANIS OF LITTLE HAVANA FOUNDATION** in Miami, Florida. The term “Participant” refers to the child/player in the Basketball League activities and includes children in participating in the Basketball League Program. By executing this document, the undersigned (i) agree to Participant’s participation in the Basketball League; (ii) acknowledge that the Basketball League involves a risk of injury or death to Participant; and (iii) agree to the limited release and indemnification provisions, all as more fully set forth below. The undersigned agree to all of this in exchange for **KIWANIS OF LITTLE HAVANA FOUNDATION’S** agreement to allow Participant to participate at no cost in the Basketball League. This Agreement binds all parties who have executed this agreement, including the Participant, as well as Participant’s Parent(s) and/or Legal Guardian(s).

PLEASE REVIEW THE PROVISIONS BELOW CAREFULLY AS THEY INCLUDE IMPORTANT DETAILED INFORMATION REGARDING THE PROVISIONS OF THIS DOCUMENT.

- 1) **Participant Waiver of Rights and Release of Liability.** Participant, Parent(s) and/or Legal Guardian(s) hereby release, waive and discharge the **KIWANIS OF LITTLE HAVANA FOUNDATION**, its agents, employees, and volunteers from all loss damage, injury, or liability arising in connection the Basketball League including all Basketball League activities, use of Basketball League facilities and equipment.
- 2) **Indemnification and Hold Harmless.** Participant, Parent(s) and/or Legal Guardian(s) further agree to indemnify and hold harmless the **KIWANIS OF LITTLE HAVANA FOUNDATION**, its agents, employees and volunteers, from and against all losses, damages, monetary awards and expenses, including all costs and attorney’s fees incurred by the indemnified parties in connection with any and all claims asserted against the **KIWANIS OF LITTLE HAVANA FOUNDATION**, its agents, employees or volunteers, brought by Participant, Parent(s) and/or Legal Guardian(s), and their respective heirs successors, assigns and legal representatives for any injury, illness, disease death, or damage to or loss of property, arising in connection with Basketball League.
- 3) **Photographs and Audio/Digital Recordings.** Participant, Parent(s) and/or Legal Guardian(s) further grant to the **KIWANIS CLUB OF LITTLE HAVANA & KIWANIS OF LITTLE**

HAVANA FOUNDATION the right to take photographs and audio/digital recordings of him or her while participating in any activities during the Basketball League and authorizes the KIWANIS CLUB OF LITTLE HAVANA & KIWANIS LITTLE HAVANA FOUNDATION, its agents, employees, and volunteers, to copyright, use and publish the photographs in print or electronically. The undersigned further agree that the KIWANIS CLUB OF LITTLE HAVANA & KIWANIS OF LITTLE HAVANA FOUNDATION may use such photographs for any lawful purpose including publicity, illustration, advertising, and website content and waive any right of compensation or ownership thereto. Your child's name or any other personal information will not be disclosed with the photograph.

- 4) **Miscellaneous.** The parties agree that the provisions of this Agreement shall be deemed severable and that the invalidity or unenforceability of any one or more of the provisions of clauses hereof shall not affect the validity and enforceability of the other provision or clauses hereof except as specifically set forth herein. The terms of this Agreement constitute the entire agreement.

RELEASE OF LIABILITY AND ASSUMPTION OF RISK

The individual named below (referred to as "I" or "me") is a member of _____ Kiwanis (club or District)(the "**Company**") and desires to participate in-person in Kiwanis meetings in the State or Commonwealth of _____ on _____ at _____. (the "**Activity**"). As lawful consideration for being permitted by the Company to engage in the Activity, I agree to all the terms and conditions set forth in this agreement (this "**Agreement**").

1. I am aware of the highly contagious nature of bacterial and viral diseases, including but not limited to the 2024 novel coronavirus disease (COVID-19) (collectively referred to herein as the "**Disease**"), and the risk that I may be exposed to or contract the Disease by engaging in the Activity. I understand and acknowledge that such exposure or infection may result in serious illness, personal injury, permanent disability, death, or property damage. I acknowledge that this risk may result from or be compounded by the actions, omissions, or negligence of others, including Company and/or its volunteers. I understand that while the Company has implemented preventative measures to reduce the spread of the Disease, the Company cannot guarantee that I will not become infected with the Disease or other infectious diseases while engaging in the Activity and that engaging in the Activity may increase my risk of exposure to and/or contracting the Disease. NOTWITHSTANDING THE RISKS ASSOCIATED WITH THE DISEASE, I ACKNOWLEDGE THAT I AM VOLUNTARILY CHOOSING TO ENGAGE IN THE ACTIVITY WITH KNOWLEDGE OF THE DANGER INVOLVED. I EXPRESSLY ACKNOWLEDGE THAT I HAVE BEEN PROVIDED AN OPPORTUNITY TO ATTEND ALL MEETINGS VIRTUALLY, AND THAT I WILL NOT LOSE THE OPPORTUNITY TO VOTE OR VOICE MY OPINIONS IF I ATTEND MEETINGS VIRTUALLY. I HEREBY AGREE TO ACCEPT AND ASSUME ALL RISKS OF PERSONAL INJURY, ILLNESS, DISABILITY, DEATH, OR PROPERTY DAMAGE RELATED TO THE DISEASE, ARISING FROM MY ENGAGING IN THE ACTIVITY, OR TRAVELING TO PARTICIPATE IN THE ACTIVITY WHETHER CAUSED BY THE NEGLIGENCE OF THE COMPANY OR OTHERWISE.

2. I hereby expressly waive and release any and all claims, now known or hereafter known, against the Company and its officers, directors, employees, agents, affiliates, members, volunteers, successors, and assigns (collectively, "**Releasees**"), on account of injury, illness, disability, death, or property damage arising out of or attributable to my engaging in the Activity and being exposed to or contracting the Disease, whether arising out of the negligence of the Company or any Releasees or otherwise (the "Released Claims"). I covenant not to make or bring any such Released Claims claim against the Company or any other Releasee, and forever release and discharge the Company and all other Releasees from liability for any and all Released Claims.

3. I am familiar with all federal, state, and local laws, orders, directives, and guidelines related to the Disease, including the Centers for Disease Control and Prevention (CDC) guidance on the Disease. I will comply with all such orders, directives, and guidelines while engaging in the Activity, including, without limitation, requirements relating to hand sanitation, social distancing, and use of face coverings. I will also follow all instructions of the Company while engaging in the Activity, I agree not to participate in the Activity if I am

experiencing symptoms of the Disease, such as cough, shortness of breath, or fever, if I have a confirmed or suspected case of the Disease, or have come in contact in the last 14 days with a person who has been confirmed or is suspected of having the Disease.

4. Solely in the event that a claim is asserted against any Releasee due to my breach of any of my obligations in Paragraph 3 above, I shall defend, indemnify, and hold harmless the Company and all other Releasees against any and all losses, damages, liabilities, deficiencies, claims, actions, judgments, settlements, interest, awards, penalties, fines, costs, or expenses of whatever kind (including reasonable attorney fees, the costs of enforcing any right to indemnification under this Agreement, and the cost of pursuing any insurance providers), that are incurred by and/or awarded against the Company or any other Releasees in any final judgment, award, or settlement that arises out of or results from any such claim.

5. This Agreement constitutes the sole and entire agreement of the Company and me with respect to the subject matter contained herein and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject matter. If any term or provision of this Agreement is determined to be invalid, illegal, or unenforceable in any jurisdiction, such term shall be severable from this Agreement and shall not affect the validity or enforceability of any other term or provision of this Agreement; further a determination that a term is invalid, illegal, or unenforceable in one jurisdiction shall not invalidate or render unenforceable such term or provision in any other jurisdiction. This Agreement is binding on and shall inure to the benefit of the Company and me and our respective successors and assigns. All matters arising out of or relating to this Agreement shall be governed by and construed in accordance with the laws of the State or Commonwealth in which the Activity occurs (the "Designated Jurisdiction"), as specified herein, without giving effect to any choice or conflict of law provision or rule, whether of the Designated Jurisdiction or any other jurisdiction. Solely in the event of a determination by any court or tribunal having jurisdiction over any dispute that arises under this Agreement, that the laws of the Designated Jurisdiction are inapplicable for whatever reason, then this Agreement shall be governed by and construed in accordance with the laws of the State of Indiana.

BY SIGNING, I ACKNOWLEDGE THAT I HAVE READ AND UNDERSTOOD ALL OF THE TERMS OF THIS AGREEMENT AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE COMPANY.
